Executive Director Summary: Addition of Mainstream Vouchers constitutes a "significant amendment" to our 5-year and annual PHA plans for Humboldt. As such, the plans and associated goal documents have been updated to reflect the addition of Mainstream vouchers. The draft PHA plan updates were reviewed by the Resident Advisory Board and no changes or concerns were brought up at the meeting or subsequently. These updates to the PHA plans require approval by the Board of Commissioners in order to make them effective.

(h2) Mainstream Attachment to Admin Plan

Executive Director Summary: Mainstream Vouchers are new to Humboldt's HCV program in 2021. While they are run nearly identical to regular HCV's, they have a couple differences such as voucher eligibility and selection from waitlist that differ from regular vouchers. For this reason, PHAs typically create an attachment to their Administrative Plan that specifically deals with differences between Mainstream and regular Housing Choice Vouchers. The draft attachment was reviewed by the Resident Advisory Board and no changes or concerns were brought up at the meeting or subsequently. This proposed attachment requires approval by the Board of Commissioners in order to officially add it to our Administrative Plan.
