Subject: Update to Resolution 1969 Regarding the Acquisition of 2335 Union Street

BACKGROUND:

On October 5th, 2022, resolution 1969 was passed and adopted to provide authorization to the Executive Director and Director of Finance of the Housing Authority of the City of Eureka (Authority) to support acquisition of the property located at 2335 Union Street (parcel #009-131-010). During acquisition of the property, the Title Officer requested that a new resolution be passed and adopted to include specific language that indicates the Authority's power to "borrow, encumber, and hypothecate" in order to obtain financing. Additionally, the Title Officer requested that the Executive Director (Cheryl Churchill) and Director of Finance (J. Dustin Wiesner) be specifically named in the resolution that grants them the authority to express such power.

Impact to Personnel/Fiscal Impact:

The updated resolution will give the Executive Director (Cheryl Churchill) and Director of Finance (J. Dustin Wiesner) the power to obtain financing to acquire the property at 2335 Union Street.

<u>Alternatives:</u>

Not passing and adopting the new resolution will result in the failure to obtain the property at 2335 Union Street.

STAFF RECOMMENDATION:

Staff recommends that the Board approve and adopt the resolution with updated language to support the acquisition and financing of the property at 2335 Union Street.

RESOLUTION NO. 1978

AUTHORIZE PURCHASE OF REAL ESTATE AND ASSIGNMENT OF AUTHORITY

WHEREAS, the two Public Housing parcels at Buhne & Summer Street (APN #009-131-009, 0.41 acres) and Union Street (APN #009-131-011, 0.36 acres), would be contiguous except for the privately owned parcel #009-131-010 located at 2335 Union Street (0.11 acres), at the corner of Buhne & Union Street: and

WHEREAS, the parcel #009-131-010 has been listed for sale as of 09/23/2022; and

WHEREAS, the City of Eureka Housing Authority Board of Commissioners supports acquisition of the aforementioned property and deems it desirable and in the best interests of this agency to acquire that certain property located at 2335 Union Street, in the city of Eureka, county of Humboldt:

WHEREAS, the City of Eureka Housing Authority is determined to grant signing and authority to certain person(s) described hereunder;

NOW, THEREFORE, BE IT RESOLVED, that this agency pursue acquisition of aforementioned property for such price and upon such terms and conditions as the Executive Director and Director of Finance of this agency may, in their discretion, deem advisable.

RESOLVED FURTHER, that the Executive Director, Cheryl Churchill and/or Director of Finance, J. Dustin Wiesner, are hereby authorized, directed, and empowered to execute, endorse and deliver in the name of and on behalf of the Housing Authority of the City of Eureka, not limited to, borrow, encumber, hypothecate, execution of deeds, powers of attorney, transfers, assignments, contracts, obligations, certificates and other instruments of whatever nature entered into for and on behalf of this agency and in its name, any and all documents required in connection with the purchase of the Property.
