Rov nqis peev nyob rau hauv peb txoj kev cog lus rau vaj tse pheej yig

Npaj Tsim Kho Tsev Dua Tshiab: Cov Lus Nquag Nug

- 1. Kuv hnov hais tias, tsev loom (Public Housing) yuav muaj txoj kev los mus tsim kho, tshais chaw, thiab nqis peev dua tshiab no. Qhov no yog txais tau li cas tiag?**
 - a. Tshais chaw los yog pib dua tshiab. Yog yuav tsim kho thiab hloov txog txoj kev pab nyiab los thawm tsev loom qhov qub mus rau ghov tshiab, xws li Section 8 kom txhauv tus ho them taus.
 - b. Tsim kho dua tshiab, yog yuav muab cov tsev qub tam sim no rhuav es ua dua cov tshiab kom ntawm dua qub. Lub hom phiaj no yuav tshwm sim rau 3-4 thaj chaw. Cov chaw no nyob hauv qab raws li nram no.
 - c. Nqis peev dua tshiab yog yuav siv nyiaj txiag lost sim kho Housing Authority cov tsev, thiab ua tsev ntxiv rau lub zej zog.
- 2. Qhov no puas yuav muaj kev cuam tshuam rau kuv qhov tsev loom? Kuv puas yuav tau kхиav los yog tshais chaw?**
 - a. Li cas los koj yeej yuav tau tshais chaw yog koj koog tsev raug xaiv. Tiam sis koj yuav tsis tau kхиav tam si no. Ib cov tsev yuav rau tsim kho kom zoo dua qub. Ib cov tsev yuav raug muab rhuav ua dua tshiab. Housing Authority yuav pab koj thiab qhia tias hnub twg koj yuav tau tawm. Cov neeg uas yuav tau tshais chaw yuav tau txais kev pab txog kev xauj tsev thiab kхиav. Thaum kho tag, koj muaj cai rov qab los nyob koj lub tsev qub los yog lub tshiab.

- 4. Lub hom phiaj no yuav ntev npaum li cas thiab thaum twg thiaj yuav tshwm sim?**
 - a. Lub hom phiaj no yuav tshwm sim kom sai li sai tau. Peb yuav koom nrog cov neeg kho vaj kho tsev thiab tsoom fwm kom kho tag rau xyoo 2030. Yuav siv li ob peb xyoos los kho vim tias yuav siv nyiaj txiag thiab sij hawm los tshais chaw rau cov neeg.
 - b. Thaum twg peb pib lawm peb yuav qhia rau nej. Peb yuav qhia tias hnub twg nej yuav tau tshais chaw mus rau qhov tshiab. Yuav siv li ob peb xyoo los mus thov kev tso cai ntawm ntsoom fwv thiab cov neeg ua hauj lwm kho vaj kho tsev. Txoj kev rhuav vaj tsev thiab tsim kho yuav tsis tshwm sim tom qab tau kev tso cai los ntawm tsoom fwv.
- 5. Yuav ua li cas tiag rau tsev neeg uas yuav tau tshais chaw?**
 - a. Housing Authority yuav ua hauj lwm nrog cov neeg ua vaj ua tsev thiab cov thawj coj los tsis ib lub tswv yim los pab cov pej xeem uas yuav tau tshais chaw. Peb yuav qhia nej li ob peb hlis ua ntej nej yuav tau khiav tsev, kom nej muaj sij hawm lo nug txog cov nstiaib lus yuas nej tsis tau taub. Housing Authority yuav thiab tham nrog nej tim ntsej tim muag txog txoj kev yuav tau tshais chaw.
- 6. Yog tias ua tau cov tsev ntau lawm, cov hoob los yog lub tsev puas yuam me dua qub?**
 - a. Cov tsev uas raug kho thiab ua dua tshiab yuav zoo ib yam li qub, nyob ntawm cov neeg kho vaj kho tsev lawv lub zeem muag xwb. Cov tsev tshiab no yuav muaj hoob kas, hoob sib tham, hoob ntxhua khaub ncaws.
- 7. Tom qab kho tsev tag, kuv lub nqi tsev puas yuav nce nqi?**
 - a. Peb yuav ntsuam xyuas txog koj cov nyiaj koj tau los ntawm ib hli ntawv. Koj tus nqi yuav raug li 30 percent. Yog hais tias koj tau nyiaj li qub, koj lub nqi tsev yuav yog li qub xwb. Peb yuav ua kom txhuav tus pej xeem them tau tsev xws li section 8 cov ntaub ntawv.
- 8. Yuav ua cas peb thiaj paub txog txoj kev yuav tshwm sim kho vaj kho tsev no?**
 - a. Peb yuav thov koj tus email los yog phone es peb thiab li hu los yog sau ntawv qhia tau rau nej sawv daws.
